

## **Official Rules and Regulations – Work Like a Boss – New Desk Contest**

**1. CONTEST PERIOD:** The Contest start date is June 6, 2016 at 9:00:01 AM EST. Contest closing date is at 16:59:59 PM EST on July 1, 2016.
